Jenn DePalma lives and works in Washington DC. Her work has been exhibited at the Transformer Gallery, G Fine Art, the Bobby Fisher Memorial Building, and Gallery 31 at the Corcoran. She was a founding member of the now defunct D'Steel[e] Society for Advanced Poetics and participates in readings in the DC area, in 2013 she co-wrote and co-published a 50-copy edition of The First Fifteen Days of October artist book with fellow artist and poet Francis Michael Terzano. Jenn is an original member of Soussi Crew, a socially radical group of artists, filmmakers, and poets that installs roving one night only exhibitions bi-annually. She is half of the performance art collaborative the YAY team, and co-owns the garden design-build company, Bona Terra LLC. Her work was most recently included in the show Some Uses of Photography, Four Washington Artists, at American University's Museum Katzen Arts Center.
